The LGU-Cabanatuan City, through the Trust Fund FY 2022 Intends to apply the sum of One Million Six Hundred Forty Thousand Eight Hundred Twenty-Four Pesos (§ 1,640,824,00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Laboratory Supplies. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The LGU-Cabanatuan City now invites bids for the above Procurement Project. Delivery of the Goods is required by Ninety (90) Days. Bidders should have completed, within Two (2) Years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. (Instructions to Bidders).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

am. Late bids shall not be accepte

- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on 29 November 2022 at 11:00 am at Conference Room, City Mayor's Office, City Hall Bidg., Kapt. Pere Subd., Cabanatuan City. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
