A complete set of Bidding Documents may be acquired by interested Bidders on 27 April 2023 from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P 5,000). The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
- 6. The LGU-Cabanatuan City will hold a Pre-Bid Conference1 on 05 May 2023 at 9:00 am at Conference Room, City Mayor's Office, City Hall Bidg., Kapt. Pepe Subd., Cabanatuan City which shall be open to prospective bidders.
