The LGU-Cabanatuan City, through the General Fund (Other Structures) FY 2023 intends to apply the sum of Sixteen Million Five Hundred Thirty-Four Thousand Three Hundred Seventy-Six Pesos and 75/100 (P16,534,376.75) being the Approved Budget for the Contract (ABC) to payments under the contract for the Furnishing of Labor and Materials for the Proposed Cabanatuan City Rice Processing Complex (Phase I) @Brgy.Macatbong, Cabanatuan City. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The LGU-Cabanatuan City now invites bids for the above-mentioned project. Completion of the Works must be accomplished within One Hundred Fifteen (115) Days.
