The LGU-Cabanatuan City, through the General Fund (GAD) FY 2023 intends to apply the sum of Four Hundred Three Thousand Six Hundred Forty Pesos and 12/100 (P403,640.12) being the Approved Budget for the Contract (ABC) to payments under the contract for the Furnishing of Labor and Materials for the Repair-Improvement of Activity Center at Sama Bajau Community @Brgy. Bakod Bayan, Cabanatuan City. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The LGU-Cabanatuan City now invites bids for the above-mentioned project. Completion of the Works must be accomplished within Forty-Three (43) Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. (Instructions to Bidders).

The Procuring Entity shall allow the bidder to present its proof of payment of the fees.
- 6. The LGU-Cabanatuan City will hold a Pre-Bid Conference1 on 10 August, 2023 at 9:00 am at the Conference Room, City Mayor's Office, City Hall Bldg., Kapt. Pepe Subd., Cabanatuan City which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before 22 August, 2023 at 9:00 am. Late bids shall not be accepted.

- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 9. Bid opening shall be on 22 August, 2023 at 9:00 am at Conference Room, City Mayor's Office, City Hall Bldg., Kapt. Pepe Subd., Cabanatuan City. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
